Please accept the following information as a submission to the Youth Jobs Strategy.

- To support students in their career education and development while at school, additional resources are needed for each school in the form of full-time career advisors.
- Currently DECYP has funded (and I assume continuing to fund) the Graduate Certificate in Career Development – many teachers have completed this certificate (including myself). We now have many teachers qualified to provide career advise and deliver career education programs at their school.
- What we now need is further commitment by DECYP in this space, through the resourcing of
  full-time career advisor positions in each school. This resource should be on top of the
  current school funding, and not expected to be funded within the current funding. With so
  many competing priorities in a school, it can be a stretch to resource a non-classroom role
  out of the current funding.
- These career advisors would then have the allocated time and capacity to work one-on-one
  with students to support them in their career journey. Every student's career journey is
  going to look very different and having the time to give them personalised and targeted
  advice and support is what is going to be more successful.
- A career advisor can also support classroom teachers through professional learning to development their career education knowledge and understanding to support students and build career education into their courses. It takes a whole school approach to support students with their career development.
- At Newstead College, career education is valued by our principal, who has allocated resources to this space through teacher line release and funding the NC uniHUB. This allows the Newstead College careers team to deliver a career program and support to our Year 11 and 12 students. We are limited in what we want to achieve in career education and to meet the needs of our students due to the time allocated. There is so much more we could achieve to support our students with additional resourcing.
